STATUS QUO

- Our ministry is mostly involved in supporting energy efficiency measures including energy supply in the housing sector, but not on the urban quarter level.
- We are engaged in supporting existing financing instruments and measures by information and special financing
- We will bring in together with the energy agency and the ARGE

 experiences from the BEEN project and experiences from our
 associated organisation Building Association Lübeck and
 Hanseatic City of Lübeck
- Our main problem is to develop a strategy for energy efficiency in urban development (with energy-saving measures, build up district heating, using renewable energies) by using existing financing programmes





STATUS QUO

- Another problem is the lack of motivation of the investors, because of the complex handling of existing financing instruments or even of the missing knowledge of those
- Therefore we need guidelines for best practise projects and general aspects for discussion with the municipalities



Project within Urb.Energy – Content (1)

- For municipalities like our associated partners in Lübeck we will learn from other partners of theirs modernization activities in the housing sector and the integrated urban development concepts, specially using renewable energy and district heating systems in quarter urban concepts
- Another point is to gain experiences for creating new and innovative financing instruments for such urban quarter projects
- The development of innovative instruments by using EU funds and national funds for energy-saving measures and energy supply could be a part of developing new instruments for the national and for the EU level



Project within Urb.Energy – Content (2)

- Developing new measures by using EU Funds for energy measures in the housing sector and integrated urban development strategies.
 Therefore the midterm evaluation of the EU Funds period 2007 – 2013 could be a chance for restructuring EU Funds supporting national programmes
- Therefore we need information, examples and a vision for new financing instruments to implement them on the regional and national level





Project within Urb.Energy – Results

- Creating new innovative financing instruments for modernization activities in the housing sector and for energy supply infrastructure for urban quarter
- Checking to implement experiences out of the project Urb. Energy with municipal partners, for e.g. associated partners in Lübeck
- Deepening interworking in developing financing instruments on the European level and for discussion on the European platform



Activities in WP3

- Comparing the developing of results and reflection for the mainly working in WP 5
- For that reason the Hanseatic City of Lübeck and/or our external expert ARGE shall take part in discussions and meetings of the WP 3





Activities in WP4

- Comparing the development of results and reflection for the mainly working in WP 5
- For that reason the Building Association Lübeck and/or our external expert ARGE shall take part in the discussions and meetings of the WP 4.
- By support of the external expert energy agency shall reflect the concepts of the target areas in contents of the developing financing instruments for the target areas in WP 5



Activities in WP5

- Analyses and reporting of the existing financing instruments
- Developing financing instruments for the concepts of the target areas in each of the countries
- Analyses of the experiences of using the existing financing programmes together with KredEx and other partners
- Developing a guideline for financing instruments and
- Support to develop a policy paper for discussion on the national and European level
